

WAIVER AND RELEASE OF LIABILITY FORM

(ASSUMPTION OF RISK, RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT)

By signing this document you will waive certain legal rights, including the right to sue.

ASSUMPTION OF RISK

1) I, the undersigned, wish to play *Airsoft*. I recognize and understand that playing *Airsoft* involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the Game and injuries resulting from tripping or falling over obstacles in the Game's playing field. In addition, I recognize that the exertion of playing *Airsoft* could result in injury or death.

2) Despite these and other risks, and fully understanding such risks, I wish to play *Airsoft* and hereby assume the risks of playing the Game. I also hereby hold harmless the "Sponsors" and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including legal fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing *Airsoft* including, without limitation, those resulting from the manufacture, selection, delivery, possession, use or operation of any and all equipment used in the Game. I hereby release the Sponsors from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsors that I am in good health and do not suffer from a heart condition or any other ailment which could be exacerbated by the exertion involved in playing the Game *Airsoft*. I further certify that I am 18 years of age or older and/or have a Parent or Guardian present.

RELEASE OF LIABILITY, WAIVER CLAIMS AND INDEMNITY AGREEMENT

In consideration of participating in *Airsoft*, I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I have, or may in the future have, against

Petawawa Airsoft or K&M Hobby Farm,

Their owner, staff, agents and representatives (all of whom are hereinafter collectively referred to as "Staff").

2. **TO RELEASE ALL STAFF** from any and all liability for any losses, damage, injury or expense that I may suffer, or that my next of kin may suffer as a result of my participation in the Game due to any cause whatsoever;

3. **TO HOLD HARMLESS AND INDEMNIFY OF STAFF** from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my participation in the Game;

4. That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of death.

PLEASE READ CAREFULLY

I HAVE READ AND UNDERSTOOD THIS AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE STAFF.
